UHI Inverness – Members of the Board of Management

The number of members on the UHI Inverness Board of Management can range between 13 and 18. Thirteen members are independent non-executive members appointed to the position. In addition, the Principal of the College is a member and there are elected support staff, teaching staff and student members. Non-executive and support and teaching staff members are generally appointed for 4 years with the option to seek an extension and then further appointment. The student members are nominated for a one-year term, with the option of reappointment for a further one term. The Principal of the College is a member of the Board if he/she holds that position. All non-executive positions are voluntary and unremunerated. The College has also appointed co-opted members with specific skills and experience relevant to the Committee onto which they have been co-opted.



Mark Sheridan - Chair of the Board of Management

Mark is a composer and has worked in music education and creativity in HE since 1990 and brings with him a wealth of knowledge and experience of the further and higher education sectors in Scotland. Mark has worked as a Reader in Music and Creativity for the University of the Highlands and Islands and a Senior Lecturer in Music and Head of Department at the University of Strathclyde where he led curriculum change.
